NCOA Scholarship Fund – Scholarships are awarded to children and spouses of NCOA members. These are non-repayable and are renewable for up to 3 years after initial grant.

WHO CAN JOIN

NCOA's membership is categorized by divisions. Eligibility for each division is outlined below. Please check annual fees on website ncoausa.org.

Regular Division: Any individual who served in any branch of the United States Armed Forces, active duty, Reserves, National Guard, retired or separated personnel who held the pay grade of E-1 through E-9 at any time prior to or at time of final separation under honorable conditions.

Veteran Division: Any individual who served in any branch of the United States Armed Forces, active duty, Reserves, National Guard, retired or separated personnel, who never held enlisted pay grade and under honorable conditions.

Associate Division: Any individual who actively supports the aims and goals of the NCOA but is not eligible for other categories of membership such as allied foreign military services.

International Auxiliary Division: Any spouse/former spouse, widow/widower, and family member 18 years of age or older of military members whether active duty, separated, veteran, Reserve, National Guard.
